Designed by Al Zikorus in the late 1950s, a Ross apprentice, Stonybrook Golf Course has provided the golfing public with a challenging, picturesque, and enjoyable layout nestled in the Hills of Litchfield, Connecticut. The Par 35 layout features 9 holes of rolling terrain and loads of charming golf character. Holes provide generous fairways and consistently manicured greens with scenic Butternut Brook weaving throughout. Golfers can expect to use every club in the bag as Stonybrook will test players with its uneven lies, changes in elevation, and undulating putting surfaces. Multiple tee placements and pin locations are available making Stonybrook a challenge to the advanced player, while providing an environment to learn and improve, fostering fun for players of all skill levels.

ONE TIME MEMBER OPERATION OF GOLF CAR WAIVER CONTRACT

During the 2023 golf season, Golf car is hereby leased by the current **LESSOR**, *Stonybrook Golf Inc.* on the day of play once rental fee has been paid by the member stated below, including those individuals under a family membership, and referred to as **LESSEE**. The intent of this agreement is that **LESSEE** is here by renting said golf cart on the day of play only.

LESSEE agrees to keep the said golf car in the same condition as when received. It is expressly understood and agreed that **LESSOR** shall not be liable for negligence or damages of any kind whatsoever, whether to person and/or property and for loss connected with, the said golf car or to any part thereof from whatever cars arising.

LESSEE shall be liable and responsible to **LESSOR** for any/all damages to the golf car occurring during the rental and any extensions there of excluding ordinary wear, and **LESSEE** shall promptly pay all repairs/replacement charges incurred by **LESSOR** in repairing, replacing, or otherwise servicing the golf car as a result of such damages as well as all the other incidental and consequential damages incurred by the **LESSOR**. **LESSEE** agrees to keep said golf car in **LESSEE'S** custody and not to sublease or re-rent same. **LESSEE** hereby certifies that he or she has full knowledge of the operation of the golf car.

The full agreement between the **LESSOR** and the **LESSEE** is contained herein, and time is made of the essence of this agreement. **LESSEE** acknowledges receipt of a golf car, in good order and repair on the day of play and hereby acknowledges that he or she is responsible for any golf car damage incurred.

Golf car operator must have a valid driver's license, register with the golf shop, and pay the rental fee on the day of play. No more than two persons or two sets of clubs per golf car. Golf car operator must follow all golf car signage and rules on the day of play. Operator and passenger must be seated at all times during operation. Reckless driving or driving under the influence is strictly prohibited. Violating golf car rules will be cause for immediate loss of cart privileges and payments. No refunds will be given.
